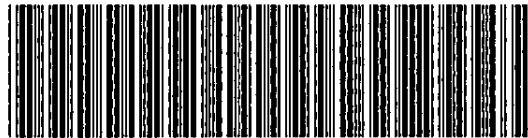

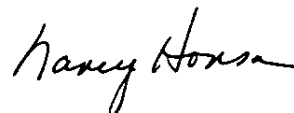

STATEMENT OF AUTHORITY
