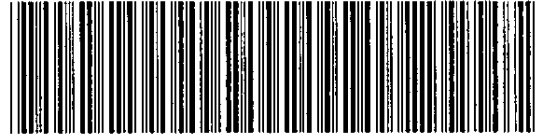

ARTICLE VI - MANAGEMENT




