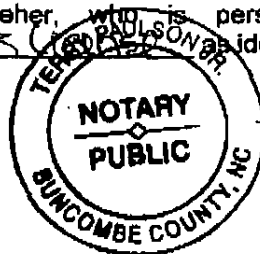
1. The name of the limited liability company is KW33NZ Realty I, LLC.
