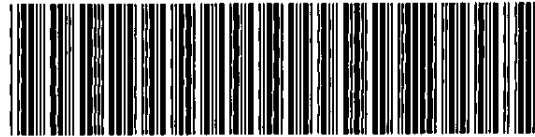

**ARTICLES OF ORGANIZATION
OF
OB/GYN SPECIALISTS OF SARASOTA, PLLC**

The undersigned, who is duly licensed to practice medicine in the State of Florida, for the purpose of forming a professional limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the professional limited liability company shall be **OB/GYN SPECIALISTS OF SARASOTA, PLLC**.

ARTICLE II - TERM OF EXISTENCE

The date when the company existence shall commence shall be the filing date of the Articles of Organization with the Department of State and the company shall have perpetual existence thereafter.

ARTICLE III - NATURE OF BUSINESS

The principal office and mailing address of this company shall be 7474 Palmer Glen Circle, Sarasota, Florida 34240.


ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT
