ARTICLES OF ORGANIZATION of SEVEN 1543, LLC

These Articles of Organization are adopted for the purpose of forming a limited liability company under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the company is Seven 1543, LLC.
