Pursuant to the requirements of Sections 608.411 and 608.4081 of the Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Organization of COFFEE ROASTER'S ALLIANCE, LLC (the "Company"), which Company was organized under the laws of the State of Florida on May 14, 2008 under Document No. L08000048363:

1. The Members of the Company adopted the foregoing amendment to the Articles of Organization on the 15th day of October, 2009.
