





ARTICLES OF ORGANIZATION FOR AG INTERIOR DESIGNS, LLC

The undersigned individual, desiring to form a Limited Liability Company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

ARTICLE I - NAME

The name of the Limited Liability Company is **AG Interior Designs, LLC**.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of this Limited Liability Company is 50 3rd Avenue South, Unit 1101, Jacksonville Beach, Florida 32250.

Additional members may be admitted upon approval of Member Andrea Glass. If a new member or members are admitted, all members must agree upon the percentage ownership interest of each member.




