

The undersigned, WILLIAM HOLLOWAY, as the subscriber to these Articles of Organization, hereby presents these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be BILLS BETTER BUYS, LLC

**ARTICLE II.
TERM OF EXISTENCE**
