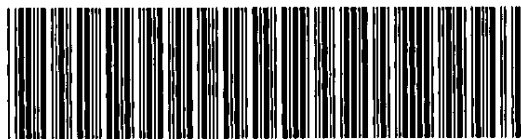

**ARTICLE I.  
NAME OF LIMITED LIABILITY COMPANY**
