FOURTH: The Company is hereby dissolved by the unanimous written agreement of all Members and Managers, pursuant to Section 608.441, Florida Statutes.


FIFTH: All debts, obligations, and liabilities of the Company have been paid or discharged.

SIXTH: All remaining property and assets held by the Company have been distributed among its Members in accordance with their respective rights and interests.


SEVENTH: There are no suits pending against the Company in any court.


