ARTICLE II - Principal Office

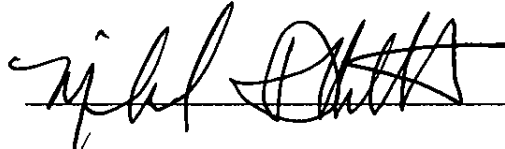

ARTICLE IV - Management

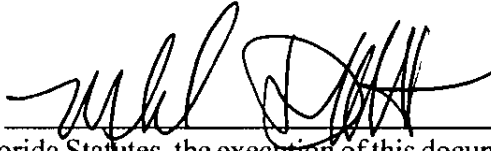

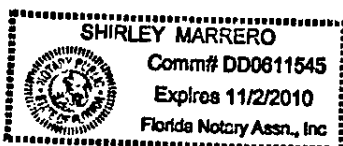
