ARTICLE I - NAME: The name of the Limited Liability Company is Miami Freedom LLC.

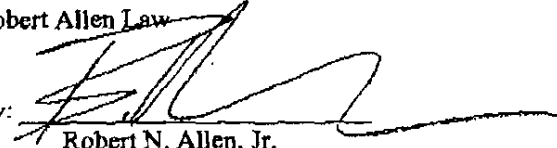

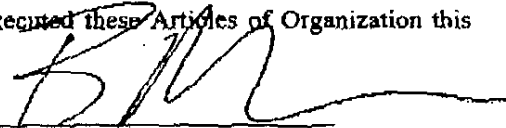
