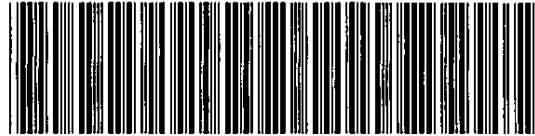



NAME
