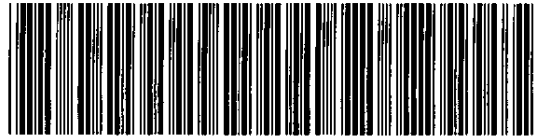



The name of the limited liability company is the MWA Capital Group, LLC.


**ARTICLE II. MAILING AND STREET ADDRESS OF THE PRINCIPAL OFFICE**

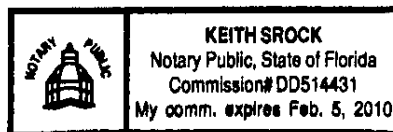
