ARTICLES OF ORGANIZATION  
OF  
FORECLOSURE LAW GROUP, P.L.

The undersigned, acting as the authorized representative of a member of Foreclosure Law Group, P.L., and pursuant to Section 608.407 of the Florida Limited Liability Company Act, and Chapter 621 of the Professional Service Corporation and Limited Liability Company Act, executes the following Articles of Organization:

ARTICLE I. NAME

The name of the professional limited liability company (the "Company") is: Foreclosure Law Group, P.L.

ARTICLE II. MAILING AND STREET ADDRESS OF PRINCIPAL OFFICE

The principal office and mailing address of the professional limited liability company shall be 2030 South Douglas Rd., Suite 206, Coral Gables, Florida 33134

ARTICLE III. INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of the Company is 2030 South Douglas Rd., Suite 206, Coral Gables, Florida 33134, and the name of the Company's initial registered agent for service of process at the address is Richard A. Muñoz, Esq.

ARTICLE IV. PURPOSE

The Company may engage in every business aspect of the practice of law and shall not engage in any business other than the practice of law.

ARTICLE V. POWERS

The Company shall have all the powers granted to all professional limited liability companies by the Professional Service Corporation and Limited Liability Company Act except that the Company shall not have the power to engage in any business other than the rendition of professional services for which it was incorporated as set forth in Article IV.

ARTICLE VI. RENDITION OF PROFESSIONAL SERVICES,

The Company shall render the professional services described in Article IV only through its agents, officers, members, and employees agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice law. The term "employees" shall not include clerks, secretaries, bookkeepers, technicians, and other assistants who are not usually and ordinarily considered by custom and practice to

be rendering professional services to the public for which a license or other legal authorization is required.

#### ARTICLE VII. MEMBERS

No person other than a professional corporation, professional limited liability company, or an individual, each of which must be duly licensed or otherwise legally authorized to practice law in the State of Florida, shall be a member of the Company.

#### ARTICLE VIII. MANAGEMENT OF COMPANY

The Company shall be a manager-managed limited liability company. The names and addresses of the initial managers are as follows:


