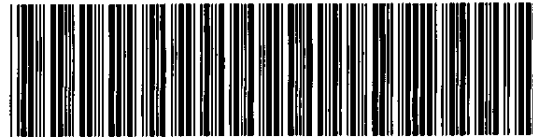

Continuation of Business

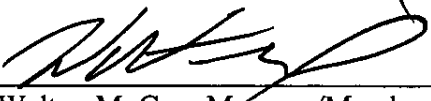

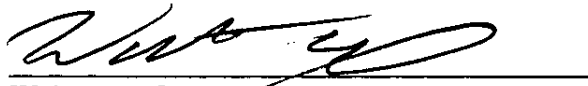
