
ARTICLE IX – MANAGEMENT



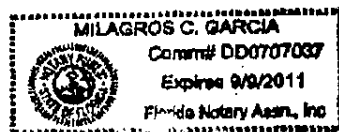


