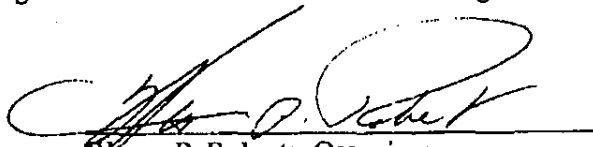

MANAGEMENT**

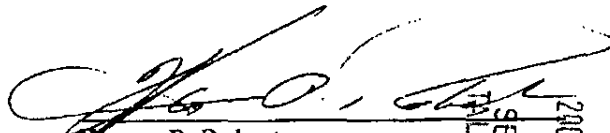
