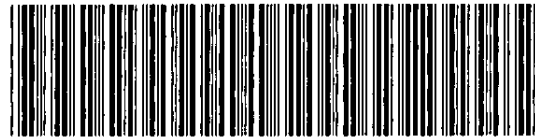

Amendment of Articles of Organization

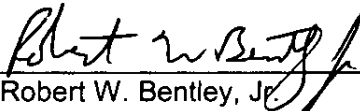

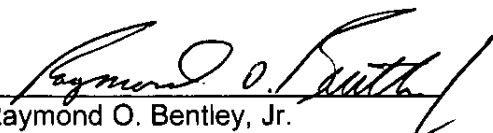

Transferability of Member's Interest

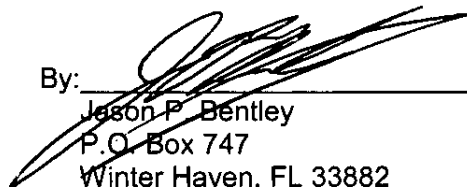

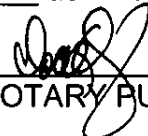
