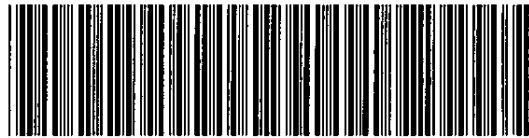

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be L.A. Gallery, LLC (the "**Company**").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be 2412 MacDill Avenue Tampa, Florida 33629, ATTN: Andres Tovar

ARTICLE III – DURATION

The Company shall commence its existence on May 1, 2008. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization or the members of the Company shall consent to dissolve the Company.

ARTICLE IV – REGISTERED OFFICE AND AGENT

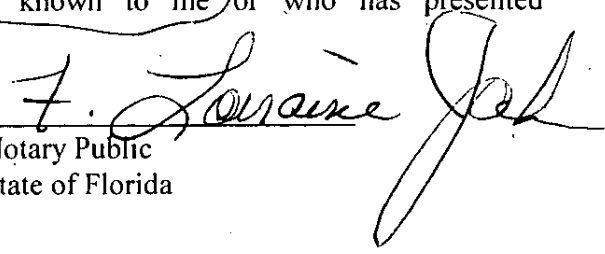

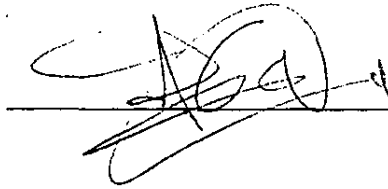
