



**ARTICLES OF ORGANIZATION  
FOR  
Barry Family Trust, LLC**

**ARTICLE I  
NAME**

The name of this limited liability company shall be Barry Family Trust, LLC.

**ARTICLE II  
DURATION**


**ARTICLE IX**


