The Articles of Organization for this Limited Liability Company were filed on May 28, 2008 and assigned Florida document number L08000053174.

- A. This amendment is submitted to amend the name of the Limited Liability Company. The new name is:

**Sizemore & Company, CPA's PLLC**

- B. Article III, Purpose is amended to the following:

The purpose of this Professional Limited Liability Company shall be to engage in every phase and aspect of the business of rendering the same professional services to the public that a certified public accountant, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice as certified public accountant. Furthermore, nothing herein contained shall be deemed to prevent the Professional Limited Liability Company from employing unlicensed persons in capacities in which they will not render such professional services to the public in the course of their employment. This limited liability company shall have all the powers conferred upon it by the laws of the State of Florida and not prohibited by the Florida Professional Service Corporation and Limited Liability Company Act; provided, however, that this corporation shall not engage in any business other than the rendering of the professional services described above. It is expressly provided that the foregoing

enumeration of specific purpose shall not be held to limit or restrict in any manner the purpose in which the limited liability company is otherwise permitted by law to engage.
