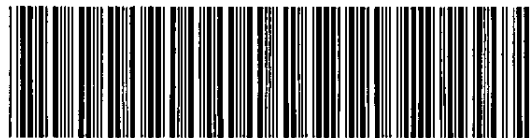

Verifier Capital Holdings, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), hereby certifies as follows:

1. The name of the Company is Verifier Capital Holdings, LLC.
2. The original Articles of Organization of the Company was filed with the Secretary of State of the State of Florida on November 29, 2005 under the name Verifier, LLC, and was subsequently amended on December 22, 2006, December 7, 2010, and February 22, 2012.
3. This Amended and Restated Articles of Organization amends, restates and integrates the provisions of the Articles of Organization, as currently in effect, pursuant to resolutions adopted by holders of a majority of the limited liability company membership interests of the Company entitled to vote thereon in accordance with Section 608.4231 of the Florida Limited Liability Company Act.
4. This Amended and Restated Articles of Organization was duly executed and are being filed in accordance with Section 608.411 of the Florida Limited Liability Company Act.
5. The text of the Articles of Organization is hereby amended and restated to read in its entirety as follows:

**ARTICLE I**

The name of the company is VCH RMR LLC (the "Company").

**ARTICLE II**

A. The mailing address and the street address of the principal office of the Company is 7280 W. Palmetto Park Road, Suite 306, Boca Raton, Palm Beach County, Florida 33433.

B. The address of the registered office of the Company in the State of Florida is 7280 W. Palmetto Park Road, Suite 306, Boca Raton, Palm Beach County, Florida 33433. The registered agent for service of process at such address is Addi Aloya.
