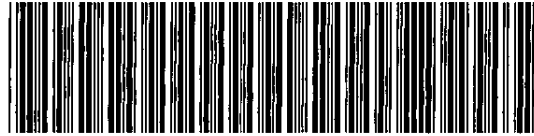



The name of the limited liability company shall be **BEST MUSIC VENUES OF LAKELAND, LLC** ("Company").




