ARTICLES OF ORGANIZATION ARTICLES OF ORGANIZATION FOR A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - Name:

The name of the Limited Liability Company is Charlotte Harbors Westwind Sport Fishing Charters, LLC

ARTICLE II - Address:


