

ARTICLES OF ORGANIZATION OF PAN AMERICAN MANAGEMENT, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

- I. Name. The name of this limited liability company is PAN AMERICAN MANAGEMENT, LLC.
- 2. <u>Duration</u>. The latest date upon which the limited liability company is to dissolve is January 1, 2051.
