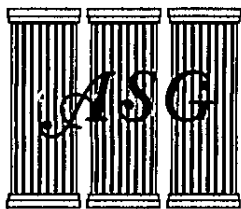

ARTICLES OF ORGANIZATION OF LRATS, LLC

ARTICLE I Name

ARTICLE V Management

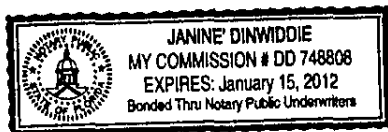

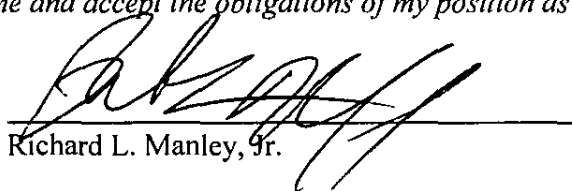
