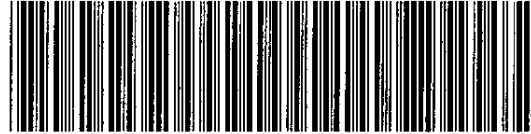

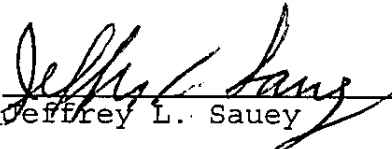

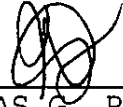
**ARTICLE V - Management**
