1. **Name.** The name of this limited liability company is Estero Condo, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

2. **Duration.** The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

4. **Place of Business.** The mailing address and street address of the Company's principal office is 14622 Aeries Way Drive, Fort Myers, Florida 33912.

8. **Certificated Interests.** The members' interests in the Company may be evidenced by certificates.
