**ARTICLES OF ORGANIZATION***of***PEDIATRIC MEDICAL MANAGEMENT, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I****NAME AND ADDRESS**


