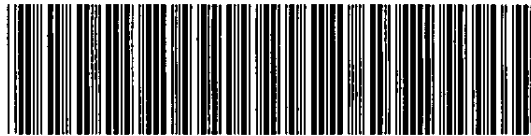

4. The limited liability company was dissolved upon unanimous consent and vote.

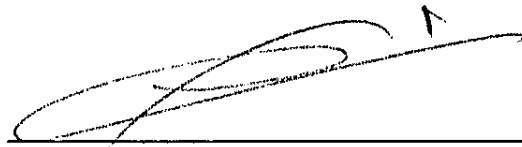
5. Adequate provision has been made for the debts, obligations and liabilities pursuant to Section 608.4421, Florida Statutes.
