**ARTICLES OF ORGANIZATION
OF
SPEECHWORKS, PLLC**

THE UNDERSIGNED Member or Authorized Representative of a Member signs these Articles of Organization and forms a professional services limited liability company (the "Company") under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621.

ARTICLE I - NAME

The name of the Company is: Speechworks, PLLC.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company is 3025 South MacDill Avenue, Suite 129-333, Tampa, Florida 33629-8171.

ARTICLE III - REGISTERED AGENT & REGISTERED OFFICE

The name and the Florida street address of the registered agent is Andrew McIntosh, Fowler White Boggs Banker P.A., 501 East Kennedy Boulevard, Suite 1700, Tampa, Florida 33602.

ARTICLE IV - PURPOSE

The general purposes for which this Company is organized shall be to render professional speech language pathology services to the general public, and to do all things in connection therewith that are customarily performed by a licensed speech language pathologist under the laws of the State of Florida. In furtherance of its corporate purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a limited liability company by the Professional Service Corporation and Limited Liability Company Act.

ARTICLE V - LIMITATION ON MEMBERSHIP

No one other than an individual who is duly licensed or legally authorized to render licensed speech language pathology services in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any member who becomes legally disqualified to render speech language pathology services shall sever all employment with and financial interest in the Company. No member of the Company may sell or transfer her/his membership interest in the Company, except to another individual or an organization eligible to become a member of the Company.
