THE UNDERSIGNED Member or Authorized Representative of a Member signs these Articles of Organization and forms a professional services limited liability company (the "Company") under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621.

ARTICLE I - NAME
