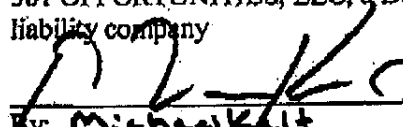
1. The name of the company is WYVERN HOTEL, LLC. The date of issuance of the Company's Articles of Organization is June 13, 2008 (document number L08000058378).
