ARTICLES OF ORGANIZATION

OF

ARTICLE I Name

The name of the limited liability company is LE MARCHE, LLC (the "Company").

ARTICLE II Principal Office

The transferee shall therefore entitled to receive only the share of profits actually distributed or other compensation paid by way of income and the return of capital contributions to which the transferring member otherwise would have been entitled by virtue of membership, nor otherwise in accordance with the provisions of the operating agreement of the Company.

ARTICLE XI Members' Rights to Continue Business

The death, retirement, resignation, expulsion, dissolution, bankruptcy, dissociation or withdrawal of any member, or the occurrence of any other event that terminates the continued
