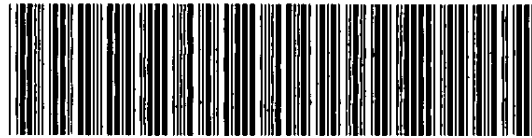

Article IV- Management.

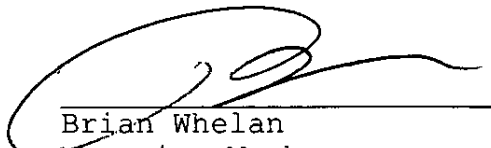

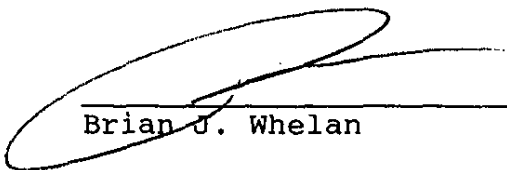

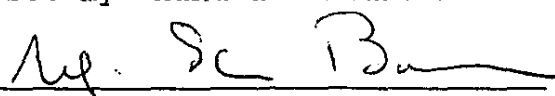
