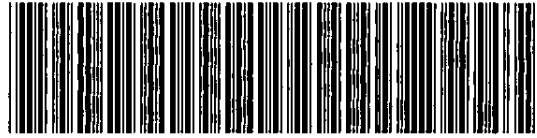



**ARTICLES OF AMENDMENT
OF
ARTICLES OF ORGANIZATION
