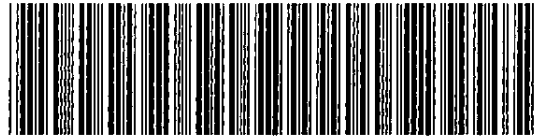

The mailing and street address of the principal office of the limited liability company is, 888 Boulevard of the Arts, Unit 207, Sarasota, Florida 34232.


