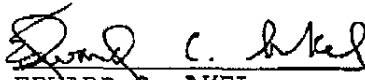
ARTICLE IV

EFFECTIVE DATE AND DURATION

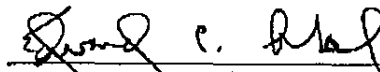
