ARTICLES OF ORGANIZATION*of***LAUDER ENTERPRISES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I**NAME AND ADDRESS**

The name of the limited liability company shall be Lauder Enterprises, LLC (the "Company"). The mailing and street address of the principal address of the Company shall be 145 Broken Pottery Drive, Ponte Vedra Beach, Florida 32082.

ARTICLE II**PURPOSES AND POWERS**
