## ARTICLES OF ORGANIZATION of TEXT YOUR MLS, LLC

08 MASO &M 3: 2:

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

### 1. **NAME.**

The name of the Limited Liability Company is **TEXT YOUR MLS, LLC** (hereinafter referred to as the "Company").

### 2. **PERIOD OF DURATION**.
