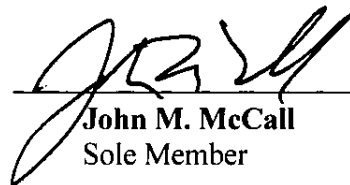
The existence of the company will commence on the date that these Articles of Organization are filed with the Florida Department of State.
