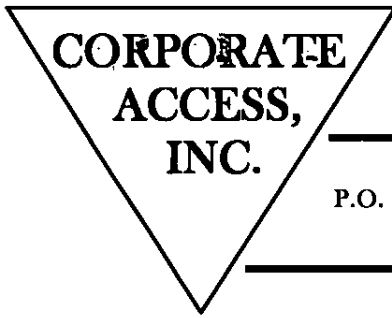

THIS IS TO CERTIFY THAT:

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Advanced Diagnostics and Hearing Solutions, LLC.

SECOND: The original Articles of Organization of Advanced Diagnostics and Hearing Solutions, LLC were filed with the Florida Department of State on June 23, 2008, and assigned Document Number L08000061566.

THIRD: The Articles of Organization of Advanced Diagnostics and Hearing Solutions, LLC are hereby amended and restated by deleting the existing Articles of Organization of Advanced Diagnostics and Hearing Solutions, LLC in its entirety and replacing it with the following:
