The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be SEA TRADING SOUTH, LLC ("Company").

ARTICLE II - ADDRESS


ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS
