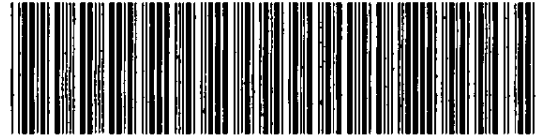


ARTICLE VI


