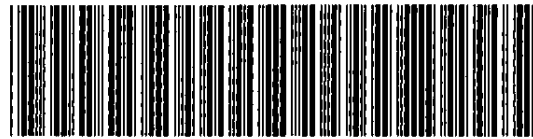

Name**
