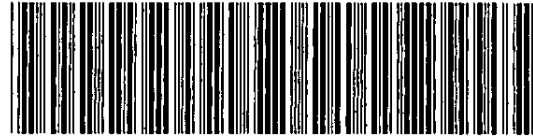


ARTICLE V


