ARTICLES OF ORGANIZATION

ARTICLE I – NAME

ARTICLE VIII – ADMISSION OF ADDITIONAL MEMBERS

In the event additional members are admitted into the Limited Liability Company, such additional members shall not have any management authority unless agreed to by at least ninety percent (90%) of the Members of the Limited Liability Company, voting in accordance with their percentage ownership interests.

ARTICLE IX – OPERATING AGREEMENT

The initial members shall have the power to adopt, alter, amend or repeal an Operating Agreement for the Limited Liability Company, which shall contain provisions for the regulation, management and operation of the affairs of the Limited Liability Company, and which shall also contain provisions relating to the respective rights of each of the members with respect to their interests in the Limited Liability Company. The Operating Agreement shall require the approval of at least ninety percent (90%) of the Members, voting in accordance with their interest in the Limited Liability Company, for any major decision.
