**ARTICLES OF ORGANIZATION
OF
ST. AUGUSTINE BREWING COMPANY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME**

The name of the limited liability company shall be ST. AUGUSTINE BREWING COMPANY, LLC ("Company"). The principal place of business of the Company in Florida shall be 5 Codova Street, St. Augustine, Florida 32084-3618. **ARTICLE II
DURATION**

The Company shall commence its existence on the date these Articles of Organization are executed. The Company's existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.


