# ARTICLES OF ORGANIZATION 09 JUN 27 AM 10: 16

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

CNM ENTERPRISES, LLC

### ARTICLE I -- NAME

The name of the limited liability company shall be CNM ENTERPRISES, LLC (the "Company").

### ARTICLE II -- ADDRESS
